Huu-ay-aht First Nations Briefing Note to HFN Executive Council

Type of Decision: Approval

Submitted by: Jeff Cook

Issue: Decision to appoint two citizens to the Lands Committee under the terms of reference and other applicable legislation.

Background: Executive Council needs to appoint two members to ensure quorum is met. To operate the committee, the nation needs up to 3 Huu-ay-aht citizens appointed by the Executive Council to serve a 1 year term along with the Chair and the Ha'wilth as other members.

Discussion: Two (2) Huu-ay-aht citizens have applied (put their names forward) to be on the Lands Committee. These citizens have stated they have a strong interests in Lands related issues; they both currently live in Anacla. Up to three (3) citizens can be chosen, or less. Dependant on current approved Budget. Commitment to attending meetings is crucial. Names submitted: Sarah Johnson and Ed Johnson.

Options:

- 1. Choose the two names submitted, supported by Lands Committee
- 2. Canvas for application at People's Assembly.
