Huu-ay-aht First Nations Briefing Note to HFN Executive Council

Type of Decision: Approval

Issue: There is currently no approved unenrolment form for Huu-ay-aht citizens to transfer out of Huu-ay-aht First Nation

Background: Maa-nulth Citizenship Committee disbanded in April 2013. We currently have no procedures in place to unenrol citizens from our nation.

Discussion: Being a Treaty Nation we have new laws to govern how our citizens are accepted into and released from our nation. We are working through the process to allow citizens to be able to transfer out of HFN. We need to implement these new laws and procedures.

Options:

1. Accept the draft Unenrolment form
2. Modify the draft Unenrolment form
3. Do nothing.

CERTIFICATON BY APPLICANT OR ENROLLEE concerning removal from the Maa-nulth Enrolment Register for Huu-ay-aht treaty enrollees, the Huu-ay-aht enrolment register and the Huu-ay-aht Citizenship Register.

I, _____ of Huu-ay-aht First Nations in the Province of British Columbia

CERTIFY THAT:

1. I am currently an individual who is on the Maa-nulth Enrolment Register for Huu-ay-aht treaty enrollees (a “Maa-nulth-aht”), the Huu-ay-aht enrolment register and the Huu-ay-aht Citizenship Register (collectively the “Registers”).
2. It is my desire, effective immediately, to have my name removed from the Registers.
3. I understand that removing my name from the Registers will mean that I am no longer enrolled with Huu-ay-aht First Nations under the Maa-nulth First Nations Final Agreement and am no longer a Huu-ay-aht citizen.
4. Without limiting paragraph 3:
 - a) I will no longer be able to vote at the People’s Assembly;
 - b) I will no longer be eligible as a Maa-nulth-aht , Huu-ay-aht treaty participant, or Huu-ay-aht citizen to any rights or benefits that flow from the Maa-nulth First Nations Final Agreement; and
 - c) I will no longer be a Maa-nulth-aht , Huu-ay-aht treaty participant or Huu-ay-aht citizen under federal, provincial or Huu-ay-aht law.
5. I confirm that I have been advised to seek independent legal advice concerning this application and the consequences of not having my name on the Registers and I confirm that I understand the consequences of not having my name on the Registers.

AND I make this solemn certification freely and voluntarily being under no duress or undue influence.
