## **BACKGROUND:**

The *Budget Act, 2014* incorrectly references in Part 7 the *Budget Act, 2012*, instead of the *Budget Act, 2013*.

The intention of Part 4 the *Budget Act, 2014* was to create both borrowing and spending authority for the amounts set out therein. While Part 4 of the *Budget Act, 2014* provides borrowing authority for the purposes listed therein, it likely does not meet the requirements of the *Financial Administration Act* with respect to providing spending authority for those items.

Executive Council has approved for presentation to the Legislature the *Budget Act, 2014 Amendment Act* to address these two issues.
