

Definitions

1 In this regulation:

“Act” means the *Referendum and Recall Act*.

Recall petition application form

- 2** (1) Form 1 in Schedule 1 is prescribed for a recall petition application under section 25 of the Act.
- (2) No recall petition application will be invalidated merely because it is not made using the prescribed form, so long as the form used is substantially similar to the prescribed form and meets the other requirements of the Act.

Recall petition form

- 3** (1) Form 2 in Schedule 1 is prescribed for a recall petition under section 26 of the Act.
- (2) No recall petition will be invalidated merely because it is not made using the prescribed form, so long as the form used is substantially similar to the prescribed form and meets the other requirements of the Act.

Application for petition to amend the Constitution form

- 4** (1) Form 3 in Schedule 1 is prescribed for an application for a petition to collect signatures to amend the *Constitution* under section 33 of the Act.

- (2) No application for a petition to collect signatures to amend the *Constitution* will be invalidated merely because it is not made using the prescribed form, so long as the form used is substantially similar to the prescribed form and meets the other requirements of the Act.

Petition to amend the Constitution form

- 5** (1) Form 4 in Schedule 1 is prescribed for a petition to amend the *Constitution* under section 34 of the Act.
- (2) No petition to amend the *Constitution* will be invalidated merely because it is not made using the prescribed form, so long as the form used is substantially similar to the prescribed form and meets the other requirements of the Act.

Commencement

- 6** This regulation comes into force on November 30, 2011.
