# 2015 Election

- General Election for Chief and Council is every four years, and the third Saturday of June.
- This 2015 Election Day is June 20
- Executive Council appointed Kit Spence as the 2015 Election Commissioner

# Candidates

- Any eligible voter may be nominated as a candidate;
- 10 nominees are required to nominate a candidate;
- Each candidate must meet the qualifications outlined in the *Elections Act*;
- Each candidate must submit a certified copy of a criminal record check, obtained within 90 days of voting day;
- A candidate can run for council and Chief Councillor, but if elected can only hold one seat

# Nomination Period

- Nomination period begins at **9:00 a.m.** on **Monday, May 4, 2015** and ends at **12 p.m. (noon)** on **Thursday, May 14, 2015.**

# Who can vote?

- Any Huu-ay-aht citizen that is at least 18 years of age as at June 20, 2015
- The citizen must not be disqualified from voting under the *Elections Act* or otherwise by law
- Duty of eligible voters:
  - ✓ Ensure their names and contact information are correct
  - ✓ Inform themselves about the candidates
  - ✓ Vote in an election
