

Purpose

- 1 The purpose of this regulation is to make minor editing corrections to Huu-ay-aht legislation enacted in 2011 and direct the Law Clerk to prepare a consolidation of Huu-ay-aht legislation.

Definitions

- 2 In this regulation, “**Act**” means the *Government Act*.

Minor revisions to Acts

- 3 In accordance with section 105 of the Act, the Huu-ay-aht Acts listed as follows are revised as set out in the copy edit notations to the Acts in Schedule A:
 - (a) *Citizenship and Treaty Enrolment Act*
 - (b) *Code of Conduct and Conflict of Interest Act*
 - (c) *Community Planning and Development Act*
 - (d) *Election Act*
 - (e) *Financial Administration Act*
 - (f) *Budget Act, 2011*
 - (g) *Government Act*
 - (h) *Interpretation Act*
 - (i) *Offence and Law Enforcement Act*
 - (j) *Referendum and Recall Act*
 - (k) *Resource Harvesting Act*
 - (l) *Tribunal Act*

Minor revisions to regulations

- 4 In accordance with section 105 of the Act, the Huu-ay-aht regulations listed as follows are revised as set out in the copy edit notations to the regulations in Schedule B:
 - (a) Criminal Convictions Regulation (*Code of Conduct and Conflict of Interest Act*)
 - (b) Gifts and Benefits Disclosure Regulation
 - (c) Criminal Convictions Regulation (*Election Act*)

- (d) Infrastructure Policy Regulation
- (e) Investment Management Policy Regulation
- (f) Purchasing Policy Regulation
- (g) Fisheries Regulation
- (h) Wildlife and Migratory Birds Regulation

Consolidation

- 5** (1) In accordance with section 105 of the Act, the Law Clerk must prepare a consolidation of all Huu-ay-aht legislation and deposit the consolidated laws in the registry.
- (2) Following the deposit of the Huu-ay-aht Laws in subsection (1), the Law Clerk must deliver a certified true copy of the Huu-ay-aht Laws to British Columbia, and if requested by Canada, to Canada.
- (3) In preparing the consolidation under subsection (1), the Law Clerk must update a Huu-ay-aht Act's Note to Reader as required by any amendments or repeal of provisions made to the Huu-ay-aht Act.
