Will continue to actively pursue a meeting with the Premier.

3)	Ensuring HFN citizens are fully informed on HFN issues.	 Continued to ensure this important responsibility is attended to, through my deliberations, discussions and meetings with the Executive Director. Gave specific instruction to Ben Clappis to report to Trudy and Sheila regarding children in care issue and his planned function as Host Home And, the Ida Seitcher child care issue

I will, by memo, asking any Executive Council member who implies or states we are not in compliance with the law, that it be put in writing so that the Executive Director can follow up with HFN legal counsel.		
7)	Promoting and maintaining a sound Huuayaht economy.	HFN took a very important step to embrace the success of the LNG project. I've made this matter my number 1 priority mainly because of citizens approved the project and it makes good business sense to move forward. And, puts badly needed cash into the projects and activities we want to implement. Worked closely with Economic Development committee to promote tourism in the territory.		
8)	Promoting Huuayaht values, culture, traditions, and language.	This is one of my most challenging responsibilities. Promoting the values is very straight forward. But promoting the culture, traditions and language to citizens who do not take this as a priority in their life is a challenge. It is time that we just practiced what we know. Emerging Issues

- 1. LNG the project needs to gain traction to make it viable.
 - Continue to work with KLNG to promotes its success including meeting with potential investors.
 - Set an active First Nation engagement strategy. Need EC approval to invite BC First Nation leaders to showcase our territory and the three main projects we are working on. If First Nation leaders don't know what we are doing. How can we expect to gain their critical political support? Especially in the current provincial political climate.
 - Inviting the Green Party may also help our cause.
 - HFN needs to actively promote project certainty.
- 2. Strategic Plan Review
 - Executive Council needs to review its portfolio responsibilities and progress to determine a work plan for the remaining 5 ½ months of the current fiscal year.
 - Also, need to review the Strategic Plan and Ancient Spirits and Modern Minds commitment charter/document. This is currently be planned.
- 3. Budget Cycle
 - I've asked John and Trudy to begin preparation for this very important activity.
- 4. Negotiations
 - LNG ongoing
 - Micro Hydro RHB assigned to assist Trevor.
 - HFN land issues RHB and Connie to meet Mark Lofthouse to get this important treaty issue underway. Meeting Island Timberlands to identify the properties we are interested in buying over the next three years. Under The Maa-nulth Final Agreement Section 2.10 Additions to Maa-nulth First Nation lands, Huu-ay-aht will be actively pursuing provincial crown lands and fee simple lands to be added to HFN lands.
 - Fiscal John, Robert and RHB to Ottawa to attend to federal fiscal matters.
 - Forestry RHB and RJD actively pursuing negotiations with Western Forest Products to finalize next timber sale agreement.
- 5. Specific Claims
 - The first two components of the IR 1 Specific Claim, the damages and the forestry compensation components are settled. Our layers from Ratcliffe and Company are currently

working on the final issue, the road issue. Kate Bloomfield provides regular updates for our review and consideration.

- 6. People Assembly Motions
 - Left in the capable hands of the Executive Director. Executive Council has reviewed and consider them but not voted on.

Progress on Key Initiatives:

- Hahouthlee Committee: The issues that are being dealt with in Lands and Natural Resources were put into the People's Assembly report with the help of Christine Gruman, the Hahoulthee Committee and the Uu-ath-luk Watershed Technical Working Group. Land and resource issues such as a wider buffer zone along the road sides: Hahouthlee Committee discussed this. There are more details provided in the logging plan map and report from Meridian. Another motion from last November was Executive Council evaluate and report to citizens on the effectiveness and the success of the food fish distribution. For my understanding this was one of the best years for distribution it was a good year even though there wasn't supposed to be Sockeye. There was another motion that executive council revises HFN hunting regulations so not to be more restrictive then provincial regulations. This was passed to the Hahoulthee committee it was revised and made to Huu-ay-aht's liking. Another motion was increase access to natural resources there was and is things being done like develop permits clarifying with HFN Forestry LP what opportunities are available to citizens to access resources in our forest tenure outside of treaty settlement lands. This was passed to the Hahoulthee Committee; it was revised and made to Huu-ay-aht's liking.
- Bamfield Community Affairs: Robert and I went to a Bamfield Community Affairs meeting. I let Robert do the reporting as I wasn't up to speed on the forestry negotiations and wasn't sure on saying anything about LNG. At the end of the month it was orange shirt day in support of residential school survivors. I am a survivor myself and Sherri Cook invited me to possibly tell my story. Miss Russell showed a film and talked about it for a while and then she invite Jeff Cook to come up and tell his story and all stories are not the same. Where Jeff didn't have any ill will against the school which I said I didcwhen Miss Russell invited me to tell my story. There were a lot of people that didn't know I was in that school. I started by saying all stories are not peaches and cream. That my story is different than Jeff's and my late sister Marie's; where she told in a digital story that, "no, nothing happened to me there and I had lots of friends". I told of the abuse and what I had to go through just to get the story out, with counsellors and lawyers and such when I went through the arbitration process. Telling this to young students and some Bamfielders was a tough go, but it's something I thought of a while back. Something I needed to do as part of my healing journey.

- NTC: HFN Council met with Judith Sawyers in her running to be president of the Nuu-chah-nulth Tribal Council. I attended the NTC AGM where Judith got voted in as president.

Update for September 2017

Finance - Progress Report

One meeting was held on September 6th. Further meetings and preparation were undertaken to organize and prepare for the financial surplus as well as the moneys coming in from external sources. Work has begun on the upcoming strategic planning and budgeting process as well.

I attended the BC Government Budget Lockup on Monday, September 11th. I believe this is a leave-over on Ministry of Finance invite lists from my time attending BC Liberal Budget Lockups, it was good to connect and understand how the current NDP government approaches the budget and how they message it.

Finance - Emerging Issues

Specific Claims

We have received and will be working on options for Council to decide upon the use of the Specific Claims moneys. This will likely be affected by the input we receive on September 30, the date of the People's Assembly.

Financial Sustainability

Meetings were convened with staff and financial advisors to tackle the four-year impending issue of overall financial sustainability. This will likely become an area of focus for myself, the department and the committee.

LNG Agreement Contingency Planning

Arrangements were made to ensure that we could continue some of the work contemplated for LNG-related activities. It is paramount that certainty of funding is achieved if we are to fulfill the expectations of our people and our ha'wiih.

LNG and LNG Advisory – Progress Report

LNG Advisory Committee

There has not yet been a meeting of the LNG Advisory Committee due to the uncertain nature of the project leading up to September 18th. It ended up being okay, but as Chair, I was loathe to call a meeting to report little but a general uncertainty. I am quite aware of the lack of meetings, but I intend on having a full-information session for committee members in late October or sometime in November, understanding that time is tight due to many travel dates in both those months.

I attended a conference regarding FN Community Engagement with SLNG. The presentation went very well, but I had understood the size of the conference was much bigger than it was... I am not certain the use of the time was worth it. Perhaps in the future, we work to target certain events that have enough of a splash.

HFN-SLNG Project Oversight Board

The Project Oversight Board did not meet in September.

LNG and LNG Advisory - Emerging Issues

[There is a dire need for an understanding of the processes for securing funding from off-take or investor. It is important that we connect with SLNG and understand what it is they need and what it is we need to know in order to plan our side effectively, but also to contribute meaningfully to the partnership. – From August Report]

Need for Messaging a Plan on Engagement

It is apparent that we need to develop and communicate to our people and our hereditary leaders our plan for engagement with First Nations regarding the project and related items. It appears as though there is a full plan in the works, but I believe that this component is more under HFN control than under SLNG control and therefore we need to come up with the plan and execute it.

Alberni-Clayoquot Regional District - Progress Report

The week-long Union of BC Municipalities meeting was held in Vancouver during the last week of September. Meetings regarding furthering reconciliation were held, and meetings with the MIRR Minister Scott Fraser was held on behalf of the ACRD. Several of the resolutions of the plenary session were very prescriptive for FNs without engagement with FNs, even though they were quite progressive in nature, it still remains necessary to educate people about FN rights and treaty rights.

The ACRD welcomes Mr. Douglas Holmes as its new Chief Administrative Officer. He brings a wealth of experience from the City of Nanaimo as its former Chief Operating Officer as well as other places throughout the province.

Alberni-Clayoquot Regional District – Emerging Issues

We need to work with the ACRD if we are still intending on furthering such things as solid waste management cooperation – garbage, recycling and even organics.

A working group with the Tseshaht First Nation was stuck in regards to the landfill that was placed next to their village in the 1970s. The current approach is one upon which we are starting anew, truly anew; but there is still some mistrust due to prior relationships being soured.

External Relations (Federal) – Progress Report

Work continued for preparations on the federal fiscal policy development process. I attended six teleconferences about both this issue and the related PM Forum Planning Subgroup.

External Relations (Federal) - Emerging Issues

Prime Minister's Forum with Self-Governing Indigenous Nations

The October date will now likely be in November. The time taken to further plan with Federal officials will likely be necessary to make the event successful and have the intended effect on their decisions regarding funding the moneys being asked for on our behalf my INAC-equivalent staffers from not just INAC, but Justice and Finance.

We should be planning to piggy-back meetings with federal officials during these sorts of events to maximize our efficient use of time. Working with Hill-Knowlton has been useful as their expertise in knowing who to speak to, when and where has been valuable for that time-efficiency.
