Notice of Posting of Voters List for the June 15, 2019 Election of Chief Councillor and Five Councillors

Notice is hereby given pursuant to Article 25 of the Huu-ay-aht Election Act that the preliminary **Voters List** for the June 15, 2019 elections for the offices of Chief Councillor and five Councillors for the Huu-ay-aht First Nations Council will be available for public inspection from April 25, 2019 until the close of voting on June 15, 2019.

Voters lists will be available for inspection at:

- Anacla Government Office, 170 Nookemus Rd, Anacla, during normal business hours, or
- Port Alberni Government Office, 4644 Adelaide Street, Port Alberni during normal business hours.

Those wishing to inspect the Voters List must agree in writing not to use or disclose the information on the list except for purposes of the Election Act using the attached form.

Eligible voters who do not wish to have their contact information publicly disclosed must notify the Election Commissioner prior to April 25, 2019.

Eligible voters may request corrections to the Voters List using the prescribed form (attached) until May 9, 2019.

All Huu-ay-aht citizens who have achieved the age of 18 as of June 15, 2015 are eligible to be included on the Voters List.
