**GOVERNMENT AGREEMENTS
AUTHORIZATIONS ACT**

The Huu-ay-aht Legislature enacts this law to confirm and provide greater certainty with respect to Executive Council's authority to enter into agreements with government.

SCHEDULE

Definitions

- 1** For the purposes of this Act and the *Financial Administration Act*, HFNA 7/2011, s. 70:

“**agreement**” means any agreement contemplated in the Treaty, including any agreement that amends or replaces an agreement contemplated in the Treaty, but does not include any non-binding agreement;

“**another government**” means Her Majesty the Queen in right of Canada or Her Majesty the Queen in right of British Columbia;

Authorization confirmed

- 2** (1) For greater certainty, Executive Council is authorized, on behalf of Huu-ay-aht First Nations, to enter into the agreements set out in Schedule A.
- (2) For greater certainty, the individual listed in Column 3 of Schedule A is authorized to sign the agreement described in Columns 1 and 2 of the same row in that table.
- (3) Executive Council may amend Schedule A by resolution.

Commencement

- 3** (1) This Act is deemed to have been continuously in force from April 1, 2011.
- (2) Subsection (1) is retroactive to the extent necessary to give full force and effect to its provisions and must not be construed as lacking retroactive effect in relation to any matter because it makes no specific reference to that matter.
