



## Information - General Local Election 2022

The following information is provided to eligible voters of the **Huu-ay-aht First Nations** regarding voting in the upcoming local government election on **October 15, 2022**.

Qualified electors of the **Huu-ay-aht First Nations** can vote for the following:

### **School District Trustee - Electoral Area #2 (Alberni Valley & Bamfield)**

#### **Am I Eligible to Vote?**

To be eligible to vote as a resident or non-resident elector, you will be required to make a declaration that you meet the following requirements:

- 18 years of age or older on the day of registration
- Canadian citizen
- resident of BC for at least 6 months immediately preceding the day of registration
- resident of OR registered owner of real property in trustee electoral area #2, and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election or otherwise disqualified by law.

#### **Who is running for office and where do I vote?**

The attached notice of Election by Voting provides all the details regarding the upcoming election including; candidates running for School District Trustee Electoral Area #2, voting dates, locations, elector eligibility, elector registration and identification required to vote.

## ELECTOR REGISTRATION

There is no need to pre-register to vote as the registration of all electors for this election will take place at the time of voting. In order to register at the time of voting, you will be required complete the application form available at the voting place and to make a declaration that you meet the requirements to be registered as set out below:

RESIDENT ELECTORS:

To register as a resident elector you must:

- be 18 years of age or older on the day of registration;

- be a Canadian citizen;
- be a resident of British Columbia for at least 6 months immediately before the day of registration (at time of voting);
- be a resident of the regional district electoral area or trustee electoral area on the day of registration (at time of voting); and
- not be disqualified under the *Local Government Act* or any other enactment from voting in an election and not otherwise disqualified by law.

#### NON-RESIDENT PROPERTY ELECTORS:

To register as a non-resident property elector you must:

- be 18 years of age or older on the day of registration;
- be a Canadian citizen;
- be a resident of British Columbia for at least 6 months immediately before the day of registration (at time of voting);
- be a registered owner of real property in the regional district electoral area or trustee electoral area for at least 30 days immediately before the day of registration (at time of voting);
- not be entitled to register as a resident elector; and
- not be disqualified under the *Local Government Act* or any other enactment from voting in an election and not otherwise disqualified by law.

In addition, for non-resident property electors:

- The only persons who are registered owners of the property, either as joint tenants or tenants in common, are individuals who are not holding the property in trust for a corporation or another trust.
- If more than one person is registered owner of the property, only one of those individuals may, with the written consent of the majority of the owners, register as a non-resident property elector.

**To register, resident electors** must produce **2 pieces of identification** (at least one with a signature). Picture identification is not necessary. The identification must prove both residency and identity.

**To register, non-resident property electors** must produce **2 pieces of identification** (at least one with a signature) to prove identity, **proof** that they are entitled to register in relation to the property, and, if there is more than one owner of the property, **written consent** from the other property owners. The **written consent** form is available for download on the Regional District website [www.acrd.bc.ca](http://www.acrd.bc.ca).

**Note: Combined BC Drivers License and Care Card count as 1 piece of ID only**

### MAIL BALLOT VOTING

#### REQUESTING A MAIL BALLOT PACKAGE:

If you wish to vote by mail, you must complete and return an **Application to Vote by Mail** to the Chief Election Officer. Application forms are available on the Regional District website by visiting [www.acrd.bc.ca](http://www.acrd.bc.ca) and choosing 'Application to Vote by Mail' **OR** by contacting the Chief Election Officer as noted below.

To be counted, your mail ballot must be received by the Chief Election Officer no later than **8:00 pm on Saturday, October 15, 2022.**
