Elder Benefits	Recommends to Executive Council to investigate securing the \$500/month benefit on a permanent basis. The finance committee directs the Executive Director to have two reports created.  1 to develop a regulation and the other for the Executive Council to use political measures to improve and increase the effectiveness of the elder benefit payments.	The Executive Director completed a report and this will be put on the Finance Committee agenda in November.  ED is recommending that there is no set regulation made for this benefit but continue with the program as it is implemented now.
Implementation of Social Services Panel Recommendations	Immediately direct that a citizen be hired to a full-time position responsible for ensuring that all 30 recommendations set out in the Social Services Panel Final Report are implemented, for monitoring ongoing implementation of the recommendations and to otherwise assist as needed in the Child and Family Wellness Department.	Refers this to the Citizen Development Committee	The committee went through the 30 recommendations and has requested that a communications piece be posted for citizens to review.
